Film Reviews:

Review of yesterdays' sixth race, the Wando Stakes. Present were Jockey Guild manager Robert King and Jockeys Patrick Husbands, Omar Moreno, Alan Garcia, Rafael Hernandez and apprentices Hannah Twomey and Diasuke Fukimoto. We discussed the first foul involving Rafael Hernandez and Omar Moreno. Rafael said he and Patrick to his outside were moving forward together and as we came up on Omar to the inside, his horse drifted out into his path and he had to check to avoid that one's heals. Omar said his horse was tiring and didn't realize his horse was drifting because it kept switching its leads. Was getting tired and didn't see the two approaching. The second foul involved Patrick Husbands, Omar Moreno and Alan Garcia. Alan said Patrick's horse came over onto Omar causing that one to come into my horse, cost me at least second money. Omar said he was fine until Patrick's horse came over on him and he had to check. Patrick said he did the best he could to keep him out but was lugging in with him hard.
