

Official Rules & Regulations
Pattison Canadian International – Best Seats at the Track

1. Contest starts at 12pm, September 15, 2018 and continues until 12am, October 8, 2018 (the “Contest Closing Date”). No purchase necessary. Limit one (1) entry per person. Pattison Outdoor Advertising and Woodbine Entertainment Group (“WEG”) are the sponsors of this contest (the “Contest Sponsors”).
 - (a) To enter, go to www.Woodbine.com, complete the entry ballot in full and submit it as instructed before the Contest Closing Date.
