

## Rules and Regulations

### 2018 Woodbine Player of the Year Series

#### Eligibility

All contestants ("Contestants") who register and participate in a minimum of three (3) 2018 Horseplayers Tournaments (the "Tournaments" and each a "Tournament") sponsored by Woodbine Entertainment Group ("WEG") will automatically be entered into the **2018 Woodbine Player of the Year Series** (the "Series"). Contestants must comply with all Rules and Regulations applicable to each Tournament in order to be eligible for the Series. Officers, employees, agents, and contractors of WEG and individuals with whom they are domiciled are not eligible to enter the Series.

The Series will run from the commencement of the first Tournament listed below until the end of the last Tournament listed below. The Series is sponsored by WEG.

#### Scoring

Series Points (the "**Points**") will be awarded based on the Contestants' standings in each Tournament. Points related to standings for each Tournament are based on the size of the pool for that particular Tournament in accordance with the point allocation schedule.

### **Multiple Entries**

If a Contestant has more than one entry in any Tournament, only the highest placing entry will earn Points. All other lower placed or tied entries of the same Contestant will be treated as non-entries for the purpose of the Series.

### **Tied Entries**

If a tie amongst unique Contestants should occur in any Tournament, for the purposes of the Series each such Contestant will receive full Points allocated for that position (for example, if there is a tie for 2nd place amongst three (3) Contestants, each Contestant will receive full 2<sup>nd</sup> place points for that Tournament).

Points from each Tournament will carry over and be added to the Contestant's Points earned for the following Tournament (if any). At the end of the Series all Points will be combined and the winners will be determined.

### **Ties in the Final Point Standings**

Ties in the final Point standings will be broken as follows: Best score in any Tournament (e.g. if one of the tied Contestants won one of the Tournaments, then that Contestant will win the tie); if still tied, best two scores; if still tied, best three scores; if still tied, the earliest Tournament entry date will be used.

### **Odds of Winning**

The odds of winning a prize depend on the number of eligible Contestants and the prognostication skills of the Contestants.

### **Winners & Prizes**

#### **The Contestant accumulating the most Series Points will be declared the Series Champion**

- 1<sup>st</sup> C\$6,500 Cash plus One (1) fully paid entry into the 2018 Woodbine Mile Horseplayers Tournament (total value to equal \$10,000)
- 2<sup>nd</sup> One (1) fully paid entry to the 2018 Woodbine Mile Horseplayers Tournament plus C\$500 Cash (total value to equal \$4,000)
- 3<sup>rd</sup> One (1) fully paid entry into the 2018 Woodbine Weekend Horseplayers Tournament plus C\$400 Cash (total value to equal \$750)

The final Series Points balance will become official following a 72-hour audit period. Winners will be notified following the audit. Official Standings will be posted on-line no later than Thursday, September 20, 2018. Only when the standings have been audited and deemed final after the 72-hour audit period, will any prizing be awarded.

WEG will attempt to contact the potential applicable prize winners after the Official Standings have been posted, by e-mail or telephone, using the contact information

provided on his/her registration for any Tournament. Potential prize winners must respond to WEG within seven (7) days after WEG either sends an email to or otherwise leaves a message for the potential prize winner (the "Winner Contact Period"). In the event that a potential prize winner cannot be contacted using the contact information provided, fails to respond to WEG within the Winner Contact Period, or is disqualified from eligibility, such potential prize winner will forfeit his/her prize and WEG shall have no liability in this regard. Prizes are not transferrable and cannot be substituted for another prize or exchanged in whole or in part for cash. WEG reserves the right to substitute any prize for a prize of equal or greater value at its sole and absolute discretion. WEG will be fully and completely released and discharged from any liability or responsibility in connection with the disqualification of a potential prize winner, failure to contact a potential prize winner using the contact information provided, or failure of a potential prize winner to respond to WEG within the Winner Contact Period. WEG shall be under no obligation to make multiple efforts to contact any potential prize winner.

Prior to the awarding of any prize, potential prize winners must (i) provide proof of age, and (ii) sign and return to WEG within forty-eight (48) hours a standard declaration and release form in favour of WEG stating that he/she has read, understood and complied with these Official Rules and Regulations, grants all consents required as contemplated in these Official Rules and Regulations, is eligible for and accepts the prize as offered, and releases WEG and its directors, officers and employees from any and all liability of any kind arising out of the Contestant's participation in this Series and receipt and use of any prize. All decisions of WEG are final and binding in all matters as they relate to this Series including, but not limited to, the awarding of any prizing.

### **Standings & Updates**

An on-line Leaderboard displaying each Contestant's registration name and Points balance will be posted, and updated after the results from each Tournament have been audited and deemed final in accordance with the rules and regulations applicable to each Tournament.

If for any reason in WEG's opinion, in its sole discretion, the Series is not capable of running as planned or if the administration, security, fairness, integrity, or proper conduct of the Series is corrupted or adversely affected, including by reason of unauthorized intervention, fraud, technical failures, or any other cause beyond its control, WEG reserves the right, at any time, in its sole discretion and without prior notice to Contestants, to withdraw, cancel, terminate, amend, modify or suspend the Series and/or any prize. WEG reserves the right, in its sole discretion, to disqualify any Contestant if said Contestant is found to be tampering with the operation of the Series or to be acting in violation of these Official Rules and Regulations or otherwise in a disruptive manner. WEG reserves the right to modify these Official Rules and Regulations without materially affecting the terms and conditions of the Series.

If, for any reason, the Series is not capable of running as originally planned, WEG, in its sole discretion, reserves the right to cancel the Series at any point prior to or during the Series. WEG shall not be held responsible for any errors, omissions or negligence that may arise or occur in connection with the Series on the part of WEG or any third party.

All decisions of WEG with respect to any aspect of this Series will be final and binding.
