Race 1, Inner turf, clear

Race 2, E. P. Taylor turf, review stretch run regarding #4 Lion Kingdom, I. Mosqueira, 1st and #1, British Royalty, S. Bahen 2nd, #4 is moving back and forth laterally under alternate urging, #1 is also lugging in through the stretch, doesn't appear to hinder the #1, Mr. Mosqueira was cited for urging, raising hand above head level while making contact and excessive, a film review was in jock's quarters via television. Second offence in calendar year, 1 day riding suspension, to be determined and a \$300.00 monetary penalty.

Race 3, Inner Turf, Stewards' Inquiry regarding #1 Souper Classy, S. Callaghan 2nd, and #6 Secret Reserve, L. Salles 5th, top of stretch. Upon review of upper pan, front tower, and apex camera angles, #1 does drift out as #6 appears to take a step in. After speaking with both riders,

Race 4, Steward's Inquiry, #3 Bodie, K. Nicholls was unseated after clipping a heel with #1 Arbeit, L. Salles. After review of apex and back tower, upper pan video camera angles and speaking with a few riders, it was determined that Mr. Salles moved out when not clear as Mr. Nicholls was visibly trying to avoid the situation by his body language just prior to going down. Mr. Salles when spoken to, was unaware of the situation. Mr. Nicholls was transported to an outside ambulance and entered concussion protocol. Is suspended until such time as he provides a fit for duty letter from a medical professional. TB #1252752
