

#### Backstretch:

- The Association Veterinarians on duty today are Dr. Oscar Calvete D.V.M. & Dr. Brett Anderson D.V.M.
- Justin Stein is training today.
- Due to the humidity today extra measures are in place for equine athletes and the participants. The Stewards are permitting heat scratches today.
- The Stewards held a review with Trainer Harold Ladouceur following an incident after race eight yesterday. Decision reserved.
- The Stewards held a review with Apprentice Jockey Pietro Moran from race three yesterday. Mr. Moran was found to be in violation of AGCO rule 9.27.05 (a) (Indiscriminate use of the crop). Mr. Moran was assessed a \$200 monetary penalty for a first offence within a one-year penalty. AGCO ruling #3278548.

- The Stewards held a review with Jockeys Da-Sean Gaskin and Keveh Nicholls concerning Mr. Nicholls being unseated shortly after the break in race nine yesterday. Mr. Nicholls stated that his horse ducked in on him and he came across the heels of Mr. Gaskins horse that caused him to be unseated. No action is required.
