- **#6 Imperial Gold (1**st) (**P. Moran**) needed some assistance post-race and was exempt from the test barn.

#3 Brutally Honest (3rd) (Civaci) broke slowly.

Race 3: All Weather

Stewards' Inquiry looking at racing action in the vicinity of the ¼ pole involving #3 Captain Clutch (3<sup>rd</sup>) (P. Moran), #4 Fleury (6<sup>th</sup>) (Aebly), and #6 Lapin de Plage (4<sup>th</sup>) (Hernandez). Moran "I thought I stayed in my path, tipped out when I was clear". Aebly "I was caught in the middle; Pietro's horse came out may have been green caused me to bump the #6". Hernandez "I think the inside horse came out, Fraser then bumped me". After further review, the Stewards deemed there wasn't enough evidence to warrant a placing. The Stewards also reviewed tape looking at the crop of Moran and the #4 at the top of the stretch...video was inconclusive.
