- Jockey Skye Chernetz was excused from her mount this afternoon.
- #11 Hemlo Gold, in race six today, was scratched as the result of a stable error. Trainer Don MacRae was found to be in violation of AGCO rule 7.07 (i) and was assessed a \$300 monetary penalty. AGCO ruling #3314571.

 Jockey Sahin Civaci (#2 Interim Analysis), (finished fifth) was found to be in violation of AGCO rule 9.01 (failure to persevere with his mount). Mr. Civaci was assessed a \$200 monetary penalty. AGCO ruling #3314681.

Going into the turn #2 Giant Teddy (Jalon Samuel), (finished second) is in tight and backs out, the #4 comes up on the heels of #2. There were no violations.
