Breeders' Cup Challenge Series "Win and You're In" Mile Division
\$1,000,000 Guaranteed
(Plus up to \$200,000 for Eligible Ontario Breds)

FOR THREE-YEAR-OLDS AND UPWARD THIS IS A NON LASIX RACE. LASIX IS NOT PERMITTED WITHIN 48 HOURS OF POST TIME FOR THIS RACE. By subscription of \$1,000 each which shall accompany the nomination and an additional \$5,000 when making entry, with an additional \$5,000 to start. The purse to be divided: 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Weight: Three-Year-Olds 123 lbs.; Older 126 lbs. Non-winners of a Gr. I race in 2026, allowed 2 lbs.; Of a Gr. II race in 2026 or a Gr. I race in 2025, allowed 3 lbs.; Of a Gr. III race in 2026 or a Gr. II race in 2025, allowed 4 lbs. *Preference for this race will be given in the following order. First Preference to Graded/Group winners in 2025/2026. Second Preference to Graded/Group earnings achieved in 2025/2026. Third Preference to total lifetime earnings. (Note: Grades as recognized by the International Cataloguing Standards Committee.) (No Canadian Bred Allowance). Final entries to be made through the entry box at the closing time then in effect for overnight events. A supplemental nomination may be made no later than the time of final entry, by a non-refundable entry fee of \$15,000 and an additional \$5,000 to start. *Plus up to \$56,625 Ontario Sired/Ontario Bred Breeder Awards. The Woodbine Mile (Gr.I) has been selected as one of the Breeders Cup "Win and You're In" Challenge Races. The nominated winner of the Woodbine Mile (Gr.I) will be entitled to automatic entry into the 2026 running of the Breeders' Cup Mile. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2026 Mile or will receive a credit equal to the Mile pre-entry and entry fee amount towards any other 2026 Breeders' Cup Championship Race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the Commonwealth of Kentucky. To be eligible for the 2026 Breeders' Cup World Championships held at Keeneland on October 30 and October 31, 2026, all horses must be pre-entered by noon (Local Standard Time at the designated place of pre-entry) on Monday, October 19, 2026. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races (US Based) and Breeders' Cup World Championship races are to be in full compliance with the Horseracing Integrity and Safety Authority's ("HISA") safety and anti-doping and medication control regulations and Breeders' Cup Limited rules, as they may be published and/or amended from time to time, all of which regulations and rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races, and all Challenge winners are subject to out-of-competition testing by the Horseracing Integrity & Welfare Unit on behalf of HISA (or their respective designees). All runners in this race are prohibited from receiving furosemide (Lasix) within 48 hours of the scheduled post time. No horse may receive intra articular (joint) injections within 14 days of post time of the race (30 days for corticosteroid injections in the fetlock). Complete veterinary treatment records must be maintained and provided upon request. Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend or change the conditions of all or any part of the Breeders' Cup Challenge "Win and You're In" race program. Each Horse entered in a Challenge Race shall be required to have a blood sample taken prior to being escorted to the paddock for purposes of determining the level of total carbon dioxide (TCO2) in such horse. Horses entered in Challenge Races shall be required to report to an area for the taking of such blood sample in sufficient time for the orderly withdrawal of the blood sample. *ALL HORSES WILL BE SUBJECT TO ALCOHOL AND GAMING COMMISSION OF ONTARIO OUT OF COMPETITION TESTING IN ACCORDANCE WITH RULE 39 OF THE RULES OF THOROUGHBRED RACING.
