Breeders' Cup Challenge Series "Win and You're In"  
\$400,000 Guaranteed  
(Plus up to \$80,000 for Eligible Ontario Breds)**

**FOR TWO-YEAR-OLDS** By subscription of \$400 each which shall accompany the nomination and an additional \$4,000 when making entry. The purse to be divided: 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Scale Weight: Colts and Geldings, 122 lbs.; Fillies, 119 lbs. (No Canadian Bred Allowance) Final entries to be made through the entry box Wednesday September 15, 2021 at the closing time then in effect for overnight events. A supplemental nomination may be made no later than the time of final entry, by a non-refundable fee of \$8,000, which includes the entry fee. \*Preference for this race will be given in the following order. First Preference to Graded/Group winners in 2021. Second Preference to Graded/Group earnings achieved in 2021. Third Preference to total lifetime earnings. (Note: Grades as recognized by the International Cataloguing Standards Committee) \*Plus up to \$45,375 Ontario Sired/Ontario Bred Breeder Awards. The Summer Stakes (Gr. I) has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Summer Stakes (Gr. I) will be entitled to automatic entry into the 2021 running of the Breeders' Cup Juvenile Turf, nominated winner will be entitled to have pre-entry and entry fees waived for the Juvenile Turf or will receive a credit equal to the Juvenile Turf pre entry and entry fee amount towards any other Breeders' Cup Championship Race, and all horses will be entitled to receive a travel stipend if travelling from a base located outside the state of California. To be eligible for the 2021 Breeders' Cup World Championships held at Del Mar on November 5 and 6, 2021, all horses must be pre-entered by noon (Local Standard Time at the designated place of pre-entry) on Monday, October 25, 2021. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free. In the event a designated Breeders' Cup Challenge turf race is taken off the turf, due to unsafe racing conditions, the horse that wins the "off the turf" race will NOT Receive an automatic qualifying position, and will NOT receive the starting fees (the total of pre-entry or entry fees) to enter the Championships in the applicable Turf Division race; provided, however, that Breeders' Cup Limited may, at its option, reinstate the "Win and You're In" status of the "off the turf" race. The decision to take a Breeders' Cup Challenge Division turf race off the turf course is under the sole discretion of the racetrack/racing association, not Breeders' Cup Limited. All runners nominated to Challenge races are subject to out-of-competition testing by the California Horse Racing Board and/or BCL. All Challenge winners are subject to out-of-competition testing conducted by the California Horse Racing Board and/or BCL. Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program. Each horse entered in a Challenge Race shall be required to have a blood sample taken prior to being escorted to the paddock for the purposes of determining the level of total carbon dioxide (TCO2) in such horse. Horses entered in Challenge Races shall be required to report to an area for the taking of such blood sample in sufficient time for the orderly withdrawal of the blood sample. Lasix is not permitted within 24 hours of post time for this race. \*ALL HORSES WILL BE SUBJECT TO ALCOHOL AND GAMING COMMISSION OF ONTARIO OUT OF COMPETITION TESTING IN ACCORDANCE WITH RULE 39 OF THE RULES OF THOROUGHBRED RACING.
