FOR TWO-YEAR-OLDS THIS IS A NON LASIX RACE. LASIX IS NOT PERMITTED WITHIN 48 HOURS OF POST TIME FOR THIS RACE. By subscription of \$500 each which shall accompany the nomination and an additional \$2,500 when making entry, and an additional \$2,500 to start. The purse to be divided: 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Scale Weight: Colts and Geldings, 122 lbs.; Fillies, 119 lbs. (No Canadian Bred Allowance) *Preference for this race will be given in the following order. First Preference to Colts & Geldings, Second Preference to Graded/Group winners in 2025. Third Preference to Graded/Group earnings achieved in 2025. Fourth Preference to total lifetime earnings. (Note: Grades as recognized by the International Cataloguing Standards Committee) *PLEASE NOTE THIS FIELD WILL LIMITED TO 12 STARTERS. Final entries to be made through the entry box at the closing time then in effect for overnight events. A supplemental nomination may be made no later than the time of final entry, by a non-refundable entry fee of \$7,500 and an additional \$2,500 to start. *Plus up to \$45,375 Ontario Sired/Ontario Bred Breeder Awards. The bet365 Summer Stakes (Gr.I) has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the bet365 Summer Stakes (Gr.I) will be entitled to automatic entry into the 2025 running of the Breeders' Cup Juvenile Turf. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2025 Juvenile Turf or will receive a credit equal to the Juvenile Turf pre-entry and entry fee amount towards any other 2025 Breeders' Cup Championship Race. All horses will be entitled to receive a travel stipend if travelling from a base located outside the state of California. To be eligible for the 2025 Breeders' Cup World Championships held at Del Mar on October 31 and November 1, 2025, all horses must be pre-entered by noon (Local Standard Time at the designated place of pre-entry) on Monday, October 20, 2025. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship Races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are herby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out-of-competition testing by the HIWU on behalf of HISA (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program. Each horse entered in a Challenge Race shall be required to have a blood sample taken prior to being escorted to the paddock for the purposes of determining the level of total carbon dioxide (TCO2) in such horse. Horses entered in Challenge Races shall be required to report to an area for the taking of such blood sample in sufficient time for the orderly withdrawal of the blood sample. *ALL HORSES WILL BE SUBJECT TO ALCOHOL AND GAMING COMMISSION OF ONTARIO OUT OF COMPETITION TESTING IN ACCORDANCE WITH RULE 39 OF THE RULES OF THOROUGHBRED RACING.
