AND IN THE MATTER OF Ashlee B. Brnjas**

Take Notice that the horse Make it Rain (ID #981020023391381) owned by Colebrook Farms and trained by Ashlee BRNJAS, which participated in the first race on July 10, 2021, finishing seventh in the seven horse field, is hereby disqualified for having been deemed to be ineligible for not fulfilling the requirements of TB Rule 6.35 If a horse, other than a first time starter, has not started in 90 days, the horse must have two workouts: one of at least a half-mile and another within 30 days (at least three-eighths (3/8) mile) of the race for which it is entered. Make it Rain provided one published workout on June 27, 2021. Also take notice that Trainer Ashlee Brnjas TRN129683, is hereby issued a monetary penalty in the amount of \$200.00 for entering an ineligible horse as per TB rule 6.28.
